Subject: Transfer/Re-admission of students for the Second year of the course in AY 2018-19

As per the resolution of Executive Council it is proposed to transfer/readmit the students of affiliated colleges who were registered earlier with the previous University during A Y 2015-16 to Dr. B A Tech University during A Y 2018-19 under the following conditions subject to UGC Regulations of 15-Oct-2015 for the award of degree D.O.No.F.13-1/2015 (CPP-II).

(A) The eligiblity criteria for the transfer/Re-admission under Transfer/Re-admission is as under

- (1) Students admitted in the A.Y. 2015-16 and who have passed in all subjects of the First year engineering at previous University will be eligible for transfer to the Second year Dr. Babasaheb Ambedkar Technologinal University engineering programme. They will have to audit the courses of First Year programme of DBATU, which were not studied by them in the previous University.
- (2) Students who were admitted in AY 2015-16 and have failed with A.T.K.T or cleared with 60% credits in the first year engineering examination of the previous University and are eligible for the Second Year in A.Y. 2018-19 in the same discipline in the same college will be considered for transfer in the Second year of Engineering Programme of DBATU in the same discipline. He/she has to appear for the examination of equivalent subject(s) of Dr. Babasaheb Ambedkar Technological University.
- (3) Students who have failed in the Second year of engineering at the previous University admitted in the A.Y. 2015-16 will be considered for transfer in the Second year of engineering programme in A.Y 2018-19 at Dr. Babasaheb Ambedkar Technological University
- (4) Students who were admitted before 2015-16 in the previous University and are still active students and have appeared for subsequent examination in the A.Y 2017-18, will be considered for Re-admission to the first year of the Engineering program in the same discipline in the same college in A.Y. 2018-19 at Dr. Babasaheb Ambedkar Technological University, subject to production of approval/NOC from Director of Technical Education, Maharashtra, for said program.
- (5) As per UGC norms referred above such students will have to complete the program by A.Y. 2020-21 to qualify for the degree No further extension will be given. The clarification of which is as under:

A student who for whatever reasons is not able to complete the programme within the normal period of N years or the minimum duration prescribed for the programme, shall be allowed two years period beyond the normal period to clear the backlogs to qualify for the degree. The general formula therefore should be as follows:

- a) Time Span = N+2 years for the completion of programme.
 where N stands for the normal or minimum duration prescribed for completion of the programme.
- b) In exceptional circumstances a further extension of one year may be granted as per the provisions in concerned Ordinances of the University.

 During the extended period, the student shall be considered as a private candidate and shall not be eligible for ranking.

(B) Subject to producing the following documents

- a) The 'No Objection Certificate' and Transfer/Migration certificate for transfer from the previous University.
- b) Reason(s) for the transfer from the previous University to Dr. B A Technological University.
- c) The C E T merit list of such candidates for the AY 2015-16 or as applicable for clause A(4) and N O C From D T E, if the student is asking transfer from different college.
- d) The copy of C E T admit card showing the allocation of seat and verified documents for transfer purpose. The documents shall have to be uploaded and verified during the online Registration and enrolment of the candidates.
- e) The Marks statement showing results of last two/four semesters, as the case may be and the attendance records for these candidates or a certification of attendance from the college.

(C) The college will fill up the Table for first year and second year students separately as given below

The said transfer is strictly for the students of first and second year of engineering course only, admitted in the said colleges in transfer round of AY 2015-16 and failed in their respective examinations conducted by the previous University in AY 2015-16/2016-17/2017-18.

Such readmitted candidate(s) will have to complete the course in stipulated time period as per the University's Rules and Regulations.

The College/Institute will take an undertaking from students as in A(5) such students opting for the transfer for second year Engineering course under Dr. B A Tech University for the A Y 2018-19 that they shall abide by the Rules and Regulations of the University.

The entire process of transfer of students admitted during A.Y. 2016-17 as per previous circular dated 17-07-2018 and the current circular dated 13-08-2018 to be completed on or before 21-08-2018.
