The Committee shall review the panels of Paper Setters, Examiners, and Moderators, suggested by the respective Board of Studies and recommend the final names to the Executive Council for approval.

The Executive Council shall approve the names for appointment as paper setters, examiners and moderators or make changes, only if necessary, but shall record the reasons for such changes.

The Director- Examination/Controller Examination shall issue the letters of the appointments to the concerned persons.

No member of the Board of Examinations or of the Committee at shall be appointed as paper-setter, examiner, and moderator for any University examination or test.

Provided that the Vice-Chancellor shall have the power to appoint a member of the Board of Examination or of the Committee, as a paper-setter, examiner, and moderator for any University examination or test, where no eligible teacher is available relating to such subject or who is not a member of Board of Examination and Evaluation or of the Committee.

The Secretary of the Board shall call the first meeting of the Board and confirm the acceptance of the membership by all members.
