- 12. RFP (Request for Financial Proposals) will be issued to only shortlisted agency/service providers based on fulfillment of eligibility criteria.
- 13. Award of contract: The institute will award the contract to the SP based on the relative weight to the quality and cost as per TOR. [The weights given to the Technical (T) and Financial (F) Proposals are: Technical = 50% and Financial = 50%, Proposals will be ranked according to their combined technical (Ts) and financial (Fs) scores using the weights (T = the weight given to the Technical Proposal; F = the weight given to the FinancialProposal; T+F= 1) as following:

$$S = Ts \times T\% + Fs \times F\%$$
