The approval is subject to fulfillment of specific conditions as enlisted in Annexure-I and general conditions as enlisted in Annexure II.

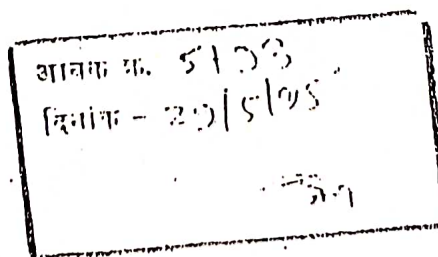

State Government of Andhra Pradesh and others etc. and later judgements, and instruct the Management/Institute/Trust or Soci shall not announce admissions directly under any circumstances

In the event of infringement/contravention or non-compliance of any of the conditions, guidelines, norms, and regulations prescribe the AICTE from time to time the AICTE or a body or person(s) authorised by it shall be free to take measures for withdrawal of the appr of recognition without consideration of any related issues and that liabilities arising out of such withdrawal would be solely that of Management/Trust/Society and/or Institutions. AICTE may inspect the institution at any time it may deem fit to note progress.

You are requested to kindly take appropriate action to implement the decision of the AICTE and communicate the progress made in regard to the Western Regional Committee of the AICTE under intimation to this office.

Note: *The approval for the additional course(s)/ increase in intake/ variation in intake is valid for two years from the date of issue of this letter for getting affiliation with respective university and fulfilling State Government requirements of admission.

The specific deficiencies for not granting increase / variation in intake / additional courses(for other programmes) to the institution are mentioned below:

- Teaching Staff are to be appointed immediately being a university department.

The additional intake is being granted based on the projections shown in the Detailed Project Report regarding additional built- up space, faculty and other facilities for the proposed intake. It may be noted that all facilities including additional built - up area and appointment of faculty should be made available before the commencement of the next academic session. Random surprise inspections would be carried out to verify facilities and if the institution is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.
