MEMORANDUM OF UNDERSTANDING

between

MGM University, Chhatrapati Sambhajnagar

AND

Dr. Babasaheb Ambedkar Technological University, Lonere

Preamble

This Memorandum of Understanding (MoU) is entered into by and between the MGM University, Chhatrapati Sambhajnagar, hereafter referred as "MGMU", with registered address at MGM University Campus, N-6, CIDCO, Chhatrapati Sambhajnagar (Maharashtra), India and "Dr. Babasaheb Ambedkar Technological University", hereafter referred as "DBATU" with registered address at Lonere-Mangaon, Dist- Raigad (Maharashtra), India. MGMU and DBATU are referred to collectively, as "parties" and individually as "party".





Purpose

This MoU aims at defining the areas of collaboration, cooperation and interaction to facilitate sharing and exchanging of advanced knowledge and procedures with a view to provide platform for mutual benefit from each other's initiatives. Both Parties are united by common interests and objectives, and they shall establish channels of communication that will promote and advance the skill development of students studying within MGM University.

Scope

This MoU sets forth the intention of the parties for increased collaboration, cooperation and interaction and does not create any legal commitments. If the Parties later agree to undertake specific joint projects with legal obligations, they will develop separate written agreements for such projects, setting out each party's contributions, deliverables and budgets. Areas other than mentioned in this MoU can also be identified and selected for collaboration by mutual agreement of both parties. This MoU will follow statutory norms applicable to both the parties.

Parties intend to

1.1 Offer an opportunity with the objective of sharing and furthering the scientific and technical know-how of both parties.

- 1.1.1 Both parties believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities to reduce time to competence of the students studying in a university.
- 1.1.2 Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests

1.2 Seek a means to identifying opportunities of improvement in curriculum design.

- 1.2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness. The parties will provide valuable inputs to each other to improve syllabus content of undergraduate and post graduate courses by suggesting new topics to be included in course syllabus.
- 1.2.2 Both organizations will provide valuable inputs in teaching / training methodology and give inputs for suitable customization of the curriculum so that the students fit into the industrial scenario meaningfully.

1.3 Examine ways to explore opportunities of visits.

- 1.3.1 Both parties will explore opportunities for faculty members and students' visit to each other's campus to get an insight into their working environment.





1.4 Discuss ways to explore opportunities of collaborative research work and projects.

- 1.4.1 Both parties will discover ways to make provisions to share the respective Research and Development facilities in order to promote joint research work and projects between both parties. The Parties shall keep each other informed of potential opportunities for skill development of students studying within the Institution and shall share all information that may be relevant to secure additional opportunities for skill development of students.
- 1.4.2 They may seek help or guidance of faculty members and support students in product as well as process modification, troubleshooting etc.
- 1.4.3 Both parties will spell out separate arrangement clearly for sharing of facilities and financial aspects before commencement of joint research work and projects.

1.5 Discuss ways to conduct joint programs.

- 1.5.1 Faculty Development Programs: Both parties may conduct training programs for skill development.
- 1.5.2 Expert Lectures and sessions: Both parties will extend the necessary support by arranging expert lectures to the faculty / students on the technology trends and in-house requirements as and when practicable.
- 1.5.3 Skill Development Programs: Both parties may arrange programs to train the students on the emerging technologies in order to bridge the skill gap and make them industry ready from time to time as possible.

Duration and Amendment

This MoU shall be effective for a period of **three years** from the date of approval. It may be modified or extended by mutual written agreement by the parties. Terms of this MoU can be amended with written consent of both parties.

Confidentiality

Each party shall keep confidentiality of any information that it receives from the other party which is marked confidential or which a party notifies the other party is confidential.

Termination

Either party may withdraw from the MoU at any time following written notification of the other party. A party intending to withdraw from the MoU must provide the other party with three months' notice of its intention to withdraw. Once terminated, neither party will be responsible for any financial or other losses, which other party may suffer.





Arbitration

Although MoU do not involve any legal obligations on MGM University, but in case of disputes relating to arrangements of this MoU, both parties will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility. The place of Arbitration shall be at Aurangabad. The Court at Aurangabad will have jurisdiction to try and decide the dispute.

This MoU will act as guideline for collaborative work between both parties to yield mutual benefit with value addition to its respective stakeholders.
