- 7. The successful bidder shall have to deposit an amount of actual weighed material security Deposit shall be forfeited and order shall be cancelled.
- 8. The successful quotation will have to remove the stock of item No.1, 3 regularly every date of intimation.
- The successful quotation will have to lift the stock of the item/s allotted to him from the University Campus and other Departments/ Institutions/ Sections at Campus at his own cost.
- 10. Shredding of the Old Assessed0 Answer-book should be done by the bidder in the University campus before lifting the same. The work should be completed in all respect from time to time within one month after allotting the job.
- 11. Overwriting in the quotation shall not be permitted. Any changes/alteration in the quotation shall be written a fresh and shall be attested by the quotation.
