At present about 340 institutes all across the state of Maharashtra are affiliated to the University. Dr. Babasaheb Ambedkar Technological University intends to empanel advocates for rendering legal opinion and contesting case in various courts (such as High Court, District Court, Tribunals, Labor Courts etc.) under the jurisdiction of Maharashtra and Hon'ble Supreme Court of India. Applications are invited from the Advocates having experience in handling matters related to Academic Institute and Universities in Court/Tribunals. #### **Minimum Qualification**

- Bachelor's degree in Law from a recognized university and registration with Bar Council of Maharashtra & Goa.

#### **Experience required for High Court & Educational Tribunals**

- 1) Professional experience of minimum 20 years as a practicing Advocate, out of which at least 05 years experience should be in handling cases (Writ petitions/appeals) related to University/Academic Institutes related matters in the High Court and Educational Tribunals.
- 2) Application must possess sound working knowledge of law and procedures of High Courts, Educational Tribunals, Services Matters, and Labor Court and must have good communication skills.

#### **Experience required for District and Subordinate Courts**

- 1) Professional experience of at least 10 years as practicing Advocate in the High Courts or District Courts out of which at least 05 years experience should be in handling cases (Writ petitions/appeals) related to University/Academic Institutes related matters in the High Court or District Courts or Educational Tribunals.
- 2) Application must possess sound working knowledge of law and procedures of District Courts, Educational Tribunals, Services Matters, and Labor Court and must have good communication skills.

3. In case, a large number of applications are received, short-listing of applications may be done. The University reserves the right to decide the criteria of short-listing.
4. Short-listed candidates may be called for interaction. The applicants will have to make their own arrangements for travel and stay for the interaction. No TA/DA will be applicable for attending the interaction.
5. All the communication regarding the intimation for the interaction, selection, etc. will be sent through email only on the email address provided by you in the application form.
6. The applicants will have to produce all original documents at the time of the interviews /interaction.
7. The University reserves the right to accept or reject any application or to cancel the complete process without assigning any reason.
8. The University reserves the rights to withdraw the names from the empanelment of advocates empanelled.
