Admission to Direct Second Year Post SSC Engineering for Vacant Seats after CAP Round (Institute Level Counselling Round - On Spot Admissions)

Applications are invited for Vacant Seats after CAP, in the Direct Second Year Diploma in Engineering from candidates satisfying eligibility as per rules published in the Information Brochure for Admission to Full Time Technical Diploma Courses by the GoM, Higher & Technical Education Department, Directorate of Technical Education Maharashtra State, Mumbai for the academic year 2024-2025.

Venue:- Diploma Building (Room No. 003)

- **Counselling Round-II of admission will be held on 10th September 2024 for filling the seats remaining vacant after Round-I.**

Note:

1. Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal or Director of the respective institution for admission at the Institution level as provided in rule 7(5) (b) and shall be filled on the basis of Inter-Se-Merit prepared by following the procedure specified in rule 8 (3) of these Rules.
2. Interested candidates are directed to register their names by submission of a registration form and must report within the scheduled time. He/she should remain present in the admission Hall till the admission process is completed.
3. Separate merit list will be prepared for Group I (HSC/MCVC) and Group II (ITI) candidate and admission will be done according to inter-se-merit of the respective group.
4. Candidate are advised to check the eligibility of course according to Schedule VI of the information broacher.
5. Candidates reporting after the display of Final merit list for the counselling round will be provided with the last merit number irrespective of his/her qualification marks.
6. Document required for Admission if the seat is offered for admission:
 - a) Print out of Final Merit Status for Admission which mentions Application ID and State General Merit Number.
 - b) All Original documents with photocopies listed in Receipt cum Acknowledgement issued by FC.
 - c) If a candidate has secured admission to another institute, then he/she has to produce a certificate of document retention and attested photocopies of documents as listed in Receipt cum Acknowledgement issued by FC.
 - d) Students who are already admitted to the Institute in previous CAP rounds are also eligible. If they get any course of their choice in this round, then first of all they have to cancel their previous admission online and the Cancellation charges will be applicable.
7. The CAP seat remains or becomes vacant after the CAP Rounds are made available for this round, the same shall be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further, if the seats remain vacant then the seats shall be filled based on Inter- Se-Merit of the applicants.
8. Candidates will be called as per merit number. If the candidate is absent he/she will lose the claim for admission or if a registered candidate of higher merit reports late during the process of counselling, the candidate may be considered for allotment of a seat available at that point of time for a particular category to which he/she belongs. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time.
9. If a seat is offered to the candidate as per merit, the candidate has to pay entire admissible fees as applicable on the same day. If the candidate fails to pay the entire fee, he/she will lose the claim of admission to the offered seat and the same seat will be offered to the other candidate as per the merit.
10. The tentative vacancy position will be displayed on the website. This being a dynamic round; the number of vacancy positions may vary during the round. Candidates are advised to apply for the course even if there is No vacancy position.
