9. Items tendered should confirm to the specification shown in the attached list when and where, full or no specifications are indicated against items in the list. Kindly furnish your full specification in accordance with accepted standards against each item tendered. - Machine serial numbers of the delivered products will be checked in their respective OEMs website to ensure the warranty of the product and genuineness of the product. Violation if any in this regard the order will be cancelled.
- OEM should have at least 10 years establishment in India. OEM must have at least 10 years Desktop PC manufacturing and the corresponding certificate to be produced at the time of bidding (MAF).
- Factory Pre-loaded / Pre-installed Windows 11 Pro Operating System. OEM letter confirming that Operating system is pre- loaded / pre- installed from OEM factory and genuine. Such declaration should not be signed by anybody below the rank of Director / Vice president of the OEM. Details of signing authority like Name, designation, and email id to be mentioned in the letter for verification, same license should be visible in OEM website. License key is to be made available in BIOS.
- Monitor, Keyboard, Mouse should be of the same make as OEM and have OEM logo/trademark embossed on them (No sticker).
- OEM Must have online system hardware diagnostics facility.
- OEM must have the facility to download updates of software, device drivers, and firmware on its public website.
- Bid specific MAF should be submitted at the time of participation and same should be confirmed by the OEM over email at the time of technical evaluation.
- Warranty details of the Product Serial Numbers should be reflected in their OEM portal.
- OEM logo embossed / etched (No stickers) for all accessories like Keyboard, Mouse, Monitor and Motherboard.
- Dedicated working toll free number of Bidder & Escalation matrix of OEM/ Bidder with working contact numbers have to be uploaded.
